EXECUTIVE ORDER NO. 22

FURTHER EXTENDING THE SUSPENSION OF DOMESTIC AND INTERNATIONAL AIR AND SEA TRAVEL OF PASSENGERS BOUND FOR BOHOL AND FURTHER ENHANCING THE COMMUNITY QUARANTINE AND ALL CALIBRATED MEASURES INSTITUTED TO ADDRESS THE ON-GOING THREATS OF COVID-19 IN THE PROVINCE OF BOHOL.

WHEREAS, the Provincial Governor is empowered to issue executive orders for the faithful and appropriate enforcement of laws and ordinances and to carry out such emergency measures during and in the aftermath of man-made and natural disasters and calamities under Section 465 (b)(1)(vii) in relation to Section 465 (b)(2)(iii) of RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Section 4 (g) of RA 11469, known as "Bayanihan to Heal As One Act" provides, that in addition to national standards of community quarantine, all Local Government Units (LGUs) are allowed to continue exercising their autonomy in matters undefined by the National Government or are within the parameters it has set; and are fully cooperating towards a unified, cohesive and orderly implementation of the national policy to address COVID-19;

WHEREAS, in line with national standards coupled with exercise of local autonomy, a Province-wide Enhanced Community Quarantine has been in place thru the institution of calibrated quarantine measures such as, among others, travel ban of in-coming passengers, suspension of classes, imposition of a province-wide curfew and stricthome quarantine, liquor ban, mandatory use of face masks, regulated operation of business establishments, imposition of "one-household one-pass" policy, as a response to the threat of COVID-19;

WHEREAS, the current realities in the ground shows that the threat of COVID-19 transmission from our neighboring provinces is still high that requires further restriction of the entry of persons into the province and enhancement of community quarantine;

NOW, THEREFORE, for and in consideration of the above premises, I, **Atty. ARTHUR C. YAP**, Governor of the Province of Bohol, by virtue of the powers vested in me by law, do hereby order:

Section 1. Extension of the suspension of domestic air and sea travel of passengers bound for Bohol. --- The suspension of domestic air and sea travel of passengers bound for Bohol until 11:59 P.M. of 12 April 2020, pursuant to Executive Order No 08 as amended in part by Executive Order No. 14, IS HEREBY FURTHER EXTENDED **until 11:59 P.M. of 30 APRIL 2020.**

Section 2. Affirming and confirming a province-wide state of Enhanced Community Quarantine. --- Consistent with national policy towards implementing

a unified, cohesive, and orderly program against COVID-19, and coupled with the exercise of local autonomy, a province-wide Enhanced Community Quarantine is hereby affirmed and confirmed to be in effect and will continue to be in full force until further notice. Hence, the following calibrated quarantine measures, such as, travel ban of in-bound passengers, suspension of classes, imposition of a province-wide curfew and strict home quarantine, 24-hours curfew of persons aged 65 years old and above, 24-hours curfew of all minors aged below 18 years old subject to exceptions under Executive Order Number 16-A; liquor ban, strict social distancing, prohibition against mass gatherings, mandatory use of face masks, regulated operation of business establishments, imposition of "one-household one-pass" policy, among others, as a response to the threat of COVID-19 shall continue to be observed by all residents of the Province.

Section 3. Strengthening all instituted quarantine measures. --- Strictest implementation of all the foregoing instituted quarantine measures is hereby ordered. Henceforth, all concerned authorities tasked to enforce/implement all prior Executive Orders issued to address COVID-19 are hereby directed to render strict compliance thereof.

Section 4. Effectivity. --- Section 1 hereof, shall take effect on 13 April 2020 at 12:00 midnight, and unless further extended shall automatically lapse at 11:59 P.M. of 30 April 2020. Sections 2 and 3 hereof, shall take effect immediately and remain in full force until this Executive Order is expressly revoked.
