### EXECUTIVE ORDER NO. 57

Series of 2021

**AN ORDER LIFTING THE STAY-HOME ORDER FOR INDIVIDUALS BELOW EIGHTEEN (18) YEARS OLD AND OVER SIXTY-FIVE (65) YEARS OLD AND MEMBERS OF THE VULNERABLE POPULATION SUBJECT TO AUTOMATIC REIMPOSITION THEREOF IN THE EVENT THAT THE PROVINCE OF BOHOL WILL BE CLASSIFIED UNDER ALERT LEVEL 4**

**WHEREAS**, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, President Rodrigo Roa Duterte has extended the declaration of State of Calamity from 13 September 2021 until 12 September 2022 through Proclamation No. 1218 (s.2021);

**WHEREAS**, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases ("IATF") issued the Guidelines on the Nationwide Implementation of Alert Level System for COVID-19 Response with Amendments on 11 November 2021 ("IATF Alert Level System Guidelines");

**WHEREAS**, on 11 November 2021, President Rodrigo Roa Duterte issued Executive Order No. 151, Series of 2021 (Approving the Nationwide Implementation of the Alert Level System for COVID-19 Response);

**WHEREAS**, under the IATF Alert Level System Guidelines, the Stay Home Order for individuals below eighteen (18) years old, those who are above sixty-five (65) years old and those who have immunodeficiency, comorbidity, or other health risks, and pregnant women or the so-called Vulnerable Population are only strictly implemented under Alert Level 4, and they are allowed freedom of movement under Alert Levels 1, 2 and 3 subject to capacity restrictions and vaccination status per Alert Level;

**WHEREAS**, under Section C (2) of IATF Resolution No. 148-F, the Province of Bohol is classified and placed under Alert Level 2 from 15-30 November 2021.

**WHEREFORE**, premises considered, and by virtue of the powers vested in me as the Provincial Governor of Bohol under Section 465 (b), (2), (iii) of the Local Government Code (R.A. 7160) and other existing laws, I, ARTHUR C. YAP, do hereby **ORDER THE LIFTING OF THE STAY-HOME ORDER FOR INDIVIDUALS BELOW EIGHTEEN (18) YEARS OLD AND OVER SIXTY-FIVE (65) YEARS OLD AND MEMBERS OF THE VULNERABLE POPULATION SUBJECT TO AUTOMATIC REIMPOSITION THEREOF IN THE EVENT THAT THE PROVINCE OF BOHOL WILL BE CLASSIFIED UNDER ALERT LEVEL 4.**

**PROVIDED THAT**, venue capacity limitation and vaccination status privileges under relevant issuances shall continue to be implemented and strictly enforced along with the minimum health and safety standards.
