EXECUTIVE ORDER NO. 52-E

Series of 2021

AN ORDER TEMPORARILY LIFTING S-PASS APPLICATION OR APPROVAL AS A REQUIREMENT FOR TRAVEL TO THE PROVINCE OF BOHOL

WHEREAS, on 01 December 2021, the undersigned issued Executive Order No. 52-D (AN ORDER EXTENDING THE EFFECTIVITY OF EXECUTIVE ORDER NO. 52-A, SERIES OF 2021, AS AMENDED BY EXECUTIVE ORDER NO. 52-B, SERIES OF 2021, AND EXECUTIVE ORDER NO. 52-C, SERIES OF 2021, TEMPORARILY ALLOWING PRESENTATION OF VACCINATION CARD AS A TRAVEL REQUIREMENT TO THE PROVINCE OF BOHOL IN LIEU OF A VACCINATION CERTIFICATE FROM 01-31 DECEMBER 2021);

WHEREAS, under Executive Order No. 52-A, Series of 2021, as amended by Executive Order No. 52-B, Series of 2021, and Executive Order No. 52-C, Series of 2021, the travel requirements to Bohol for fully-vaccinated individuals are as follows: a) Vaccination Card issued by any Local Government Unit ("LGU"), Department of Health ("DOH")-accredited medical institution, private company, and foreign country or any State/Province thereof authenticated by DOH-Bureau of Quarantine ("BOQ"); b) Government-issued Identification Card; and c) S-Pass (Approved or Pending Approval);

WHEREAS, for unvaccinated individuals, they are required to present the following: a) negative RT-PCR Result taken seventy-two (72) hours prior to departure; b) Government-issued Identification Card; and c) approved S-Pass Application, except for minors eleven (11) years old and below accompanied by either their fully vaccinated parent/s or guardian/s who are exempted from RT-PCR Testing;

WHEREAS, the onslaught of Super Typhoon Odette resulted to the breakdown of power utilities and telecommunication services which makes it difficult for travelers and focal persons to communicate with each other for purposes of S-Pass application or approval as a requirement for travel to the Province of Bohol;

WHEREFORE, premises considered and by virtue of the powers vested in me as Provincial Governor of Bohol under section 465 (b) (2) (iii) of the Local Government Code (R.A. 7160) and other existing laws, I, ARTHUR C. YAP, do hereby issue **AN ORDER TEMPORARILY LIFTING S-PASS APPLICATION OR APPROVAL AS A REQUIREMENT FOR TRAVEL TO THE PROVINCE OF BOHOL**.

Fully vaccinated travelers will only be required to present their Vaccination Certificate/Card and Government-issued Identification Card. Unvaccinated travelers shall be required to present a negative RT-PCR/Saliva RT-PCR result taken seventy-two (72) hours prior to departure. Children eleven (11) years old and below who will be accompanied by either their fully vaccinated parent/s or guardian/s shall be exempted from RT-PCR Testing.

This Order shall take effect immediately upon its issuance.
