AN ORDER EXTENDING THE EFFECTIVITY OF EXECUTIVE ORDER NO. 52-A, SERIES OF 2021, AS AMENDED BY EXECUTIVE ORDER NOS. 52-B, 52-C, 52-D AND 52-E, ALL SERIES OF 2021, PRESCRIBING A LESS STRINGENT REQUIREMENT FOR TRAVEL TO THE PROVINCE OF BOHOL UNTIL 28 FEBRUARY 2022

WHEREAS, under Resolution No. 154-D, Series of 2021, issued by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases, all provinces, including the Province of Bohol, was placed under Alert Level 2 from 01 January 2022 until 15 January 2022;

WHEREAS, to fast track the recovery and rehabilitation efforts in the entire Province of Bohol after the devastation and destruction left by Super Typhoon Odette, there is a need to maintain the current relaxed travel requirement to the Province of Bohol under Executive Order No. 52-A, Series of 2021, as amended by Executive Order Nos. 52-B, 52-C, 52-D and 52-E, all Series of 2021;

WHEREFORE, premises considered and by virtue of the powers vested in me as Provincial Governor of Bohol under Section 465 (b) (2) (iii) of the Local Government Code (R.A. 7160) and other existing laws, I, ARTHUR C. YAP, do hereby issue **AN ORDER EXTENDING THE EFFECTIVITY OF EXECUTIVE ORDER NO. 52-A, SERIES OF 2021, AS AMENDED BY EXECUTIVE ORDER NOS. 52-B, 52-C, 52-D AND 52-E, ALL SERIES OF 2021, PRESCRIBING A LESS STRINGENT REQUIREMENT FOR TRAVEL TO THE PROVINCE OF BOHOL UNTIL 28 FEBRUARY 2022.**

For fully vaccinated travelers, only a Vaccination Certificate or Vaccination Card shall be required. For partially vaccinated and unvaccinated travelers, they shall be required to present a negative RT-PCR Test Result taken seventy-two (72) hours prior to departure.

Minors eleven (11) years old and below shall be exempted from RT-PCR Testing as long as they are accompanied by either fully vaccinated parent/s or guardian/s.

S-Pass shall continue to be suspended and shall no longer be required to be presented for travel to the Province of Bohol.

This Order shall take effect immediately upon its issuance.
